This key fob is issued to the above guest and is Not transferable and is for his/her personal use using these facilities at their own risk and under the following conditions:

ALL POSTED RULES AT POOL AND JACUZZI WILL BE ENFORCED

1. The key fob is not to be lent out, transferred or misused in any way. I will report the loss or theft or malfunction of the key fob immediately to the main office.
2. I am responsible for any visitors of mine that I may bring into the select rooms and will be responsible for cleaning up after myself/ourselves. If I want my guests to have their own key fob – I will come to office to get them a key fob assuming responsibility for them. If I am not here, I will in writing give my permission for them to purchase a key fob again assuming all responsibilities.
3. No persons under the age of 18 allowed in the Adult Billiards room for any reason.
4. No persons under the age of 16 unless accompanied by an adult in the Exercise room. No alcoholic beverages in the Exercise room.
5. No persons under the age of 12 in the pool unless accompanied by an adult. There is **NO LIFEGUARD on duty in the pool area**. No glass containers in the pool area. **No children under the age of 21 Years allowed in Jacuzzi – with or without parent.**
6. **All children under the age of 4 must wear double (2) swimmer/water diaper under their swim suit if they are going into pool.**
7. Use of these facilities fall under the current **COMMUNITY RULES & REGULATIONS** and any abuse of same may result in loss of use of said facilities and/or cancellation of your site at Hidden Shores.
8. A non refundable \$5 charge is required for each key fob, one key fob per person. This charge can be added to your monthly bill.
9. No swimming in Pool/Jacuzzi after posted hours.
10. **No Diving – Shallow Pool**
11. All persons using pool/Jacuzzi do so at their own risk.
12. No running in Pool area.
13. No Pets Allowed in Pool area.
14. No glass containers in Pool area.
15. No food in Pool or Jacuzzi.
16. Smoking not allowed in Pool area.
17. Pool/Jacuzzi are for private use only.
18. Proper attire must be worn at all times in Pool and Jacuzzi.
